4. FIRST AID MEASURES

For advice, contact a Poisons Information Centre (e.g. phone Australia 131 126; New Zealand 0800 764 766) or a doctor at once.

Inhalation:

Remove to fresh air, ensure breathing can be maximised by removing any clothing that maybe obstructing mouth or throat. Give plenty of water as tolerated.

Skin Contact:

If spilt on large areas of skin or hair, immediately drench with running water and remove clothing. Continue to wash skin and hair with plenty of water (and soap if material is insoluble) until advised to stop by the Poisons Information Centre or a Doctor. Seek immediate medical assistance. .

Eye Contact:

Immediately wash in and around the eye area with large amounts of water for at least 15 minutes. Eyelids to be held apart. Remove clothing if contaminated and wash skin. Seek medical assistance.

Ingestion:

Immediately rinse mouth with water. If swallowed, do NOT induce vomiting. Give a glass of water, Never give anything by mouth to an unconscious person. If vomiting occurs give further water. Seek immediate medical assistance.

Medical attention and special treatment:

Treat as Heavy Duty Spray & Wipe Alkaline Cleaner. This product is alkaline and very corrosive. Soluble in water.
